Richard was aware of the excellent work that everyone does at the school and is now enjoying the opportunity to be part of a team supporting this diverse provision.

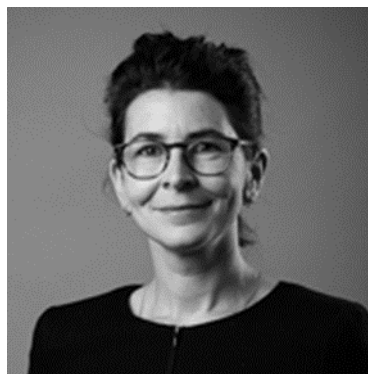
Richard is married to Sue Styles who teaches at St Anthony's, they have four children between them and three lovely Grandchildren.
